Second Party is also a higher educational institution namely:

NARAJOLE RAJ COLLEGE, NARAJOLE, PASCHIM MEDINIPUR, WEST BENGAL, PIN 721211

First Party and Second Party believe that collaboration and cooperation between themselves will promote effective use of each of their resources and provide each one of them enhanced opportunity. Both parties, legal entities in themselves desire to sign a

MoU for advancing their mutual interest. Now therefore, in consideration of the mutual promises set forth in this MoU, the parties hereto agree as follows.

CLAUSE 1: PURPOSE & SCOPE

The parties recognize the benefits to be derived from increased collaboration, cooperation and interaction for the purpose of promotion and understanding of high performance in awareness, activities and organizing various programmes including conferences, seminars, study-tours, field-visits and other awareness activities. The purpose of this MoU is to define fundamental areas of socio-cultural-academic aspects in which the parties desire to work together in the future for their mutual benefit to foster a collaborative framework. The purpose of this agreement is purely academic. Both the Parties are intending to specifically undertake:

CLAUSE 2: MODE OF OPERATION

Both parties will provide necessary support for effective implementation of the MoU within the institutional rules, regulations and procedures. This MoU shall be effective from the date it is signed by both the parties.

Within the broad parameters of the MOU, **both parties** work on awareness activities, internship programmes, development of facilities etc. any financial commitment for joint activities under this MoU shall be subject to the approval by the competent authorities of the respective organization. The activities under this MoU shall be coordinated, monitored and recorded by the **Internal Quality Assurance Cell (IQAC)** of **MAHISHADAL RAJ COLLEGE** and **Internal Quality Assurance Cell (IQAC)** of **NARAJOLE RAJ COLLEGE**. The visitors will be bound by the rules and regulations, as well as the code of conduct of the host institution.

CLAUSE 3: FINANCIAL ARRANGEMENTS

No financial commitment is required /involved to execute the terms and conditions of this MoU. In case of any financial assistance received as extramural grant to any party of this MoU, then that will be duly audited and acknowledged.

CLAUSE 4: PERIOD AND APPLICABILITY

Unless terminated earlier as per the provision herein contained, this agreement shall be valid for **an initial period of 3 (Three) years** from the date of signing of this MOU. Subsequently, this agreement may be renewed for such further term or terms as may be mutually agreed upon.

CLAUSE 5: TERMS AND CONDITIONS

It is mutually understood and agreed by and between the Institutes viz. **MAHISHADAL RAJ COLLEGE** and **NARAJOLE RAJ COLLEGE** that:

1. **MAHISHADAL RAJ COLLEGE** and **NARAJOLE RAJ COLLEGE** may mutually use and share educational facilities and may jointly guide students at various levels of academia.
2. **MAHISHADAL RAJ COLLEGE** and **NARAJOLE RAJ COLLEGE** may mutually conduct professional courses / training programmes / workshops / seminars / conferences / field study for which ***certificates will jointly be issued by both the Colleges, to all candidates after successful completion of the same.***
3. In case of any dispute resulting from or related to this MoU, the Parties agree to attempt to resolve such dispute amicably. This MoU shall be governed and construed according to the laws of the country for each participating party. Any dispute will be jointly resolved by involving the **Principal of MAHISHADAL RAJ COLLEGE** and the **Principal of NARAJOLE RAJ COLLEGE**, in a spirit of independence, mutual respect, and shared responsibility.
4. The MoU may be terminated by either party after giving a notice of **six months (180 days)** provided that this clause will be operative only if either party violates the terms of MoU or if the parties feel that no useful purpose would be served by further continuing it either due to change in circumstances or change in constituting parties.
5. It is expressly agreed that the First Party and the Second Party are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any presentations or create any
