

Anti-Ragging Cell



Policy Document

Introduction to Anti-Ragging Cell (ARC)

The Anti-Ragging Committee serves as a supervisory and advisory committee in sustaining a culture of ragging-free environments on college campuses. The Anti-Ragging Committee is active in developing strategies and action plans to combat the menace of ragging at the college through a variety of initiatives.

Objectives of ARC

- 1. ARC aims to prevent and safeguard students from ragging.
- To raise students' understanding about the negative impacts of ragging, its in fluence on human life, and the repercussions of participating in the act of ragging.
- 3. To receive and handle complaints through the ARC.
- 4. To initiate legal action as necessary, given the severity of ragging incidents.

What is Ragging?

Ragging includes any one or more of the following behaviours:

- Any behaviour on the part of one or more students that has the effect of making fun of, mistreating, or treating another student rudely, whether through written or spoken words or deeds.
- Engaging in boisterous or unruly behaviour by one or more students that irritates, burdens, injures physically or psychologically, or instils fear or apprehension in any new student or other student.
- Requesting that a student perform an act that they would not typically
 perform and that would cause them to feel ashamed, tormented or
 embarrassed in a way that would negatively impact their physical or mental
 health or the mental health of any other student.
- Any action taken by a senior student that hinders, interferes with, or upsets a
 freshmen or other student's routine academic activity.
- Making use of a new student's or any other student's assistance to finish acad emic assignments given to a single student or group of students.
- Any financial extortion or coerced spending placed on a new student or any other student by other pupils.
- Physical abuse, including sexual abuse, homosexual attacks, stripping, forcing obscene gestures, causing bodily harm, or posing a threat to health or person.



- Harassment of freshers or other students through spoken comments, emails, blogs, or public insults, including those who get enjoyment from their discomfort.
- Any behaviour that harms a student's mental health or self-confidence, either intentionally or unintentionally, or displays power, authority, or superiority over other students.

Duties of Ragging Grievant

- A written complaint has to be submitted to the any member of Anti-Ragging Cell (ARC) or to the Anti-Ragging Cell Box describing the ragging instance completely with date, time and place of happening.
- The complaint should contain the identity of the complainant and the identity of the alleged.
- 3. The confidentiality of the complainant and any other applicable issues shall be maintained Anti Ragging Committee

Redressal of Ragging Cases

In case of any ragging case reported in the college campus

- Members of the Anti-Ragging Cell (ARC) must quickly secure the complainant and/or victim, and take him to counselling.
- 2. The complainant or victim must submit a written complaint detailing the incident, including date, time, and location.
- Obtain the identification of the complainant and/or victim, including their name, semester, section, contact number, email address, and parent's name and contact information.
- Obtain the alleged's identity, including their name, branch, semester, section, contact number, email address, and parent's name and contact information.
- The complaint must be documented in a file with committee members.
- 6. A meeting will be conducted in conjunction with the chairman to settle the matt er and decide on action.
- 7. If found guilty, the AntiRagging Cell (ARC) will suggest appropriate actions to the institution's Head.

Actions

Punishment for ragging should be severe enough to deter future incidents. The institution's Anti-Ragging Committee will determine the appropriate punishment based on the facts of each ragging occurrence and its gravity.

Depending on the type and gravity of the offence as determined, the possible sanctions for individuals found guilty of ragging at the institution level shall be



one or a combination of the following:

- (i) Cancellation of admission
- (ii) Suspension from attending classes
- (iii) Withholding/withdrawing scholarship/fellowship and other benefits
- (iv) Debarring from appearing in any test/examination or other evaluation process (v) Withholding results
- (vi) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- (vii) Suspension/expulsion from the hostel
- (viii) Rustication from the institution for period ranging from 1 to 4 semesters
- (ix) Expulsion from the institution and consequent debarring from admission to any other institution.
- (x) Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

GUIDELINES ON GRIEVANCE REDRESSAL MECHANISM

1. PREAMBLE

- 1) Narajole Raj College affiliated to Vidyasagar University is dedicated to provide an environment towards a safe fair and harmonious learning and appropriate work environment. The college has its own full proof system for grievance redressal of students as well as for teaching and non teaching staff within a reasonable time.
- 2) The grievances those are considered for redressal are classified as Academy and non Academy matters. Those are such as work assessment, victimisation, attendance, charging of fees, examination conducting, harassment by fellow students or teachers or staffs as the case would be. Now to combat any grievance, grievance redressal cell (GRC) has been from as per UGC regulation to deal with day to day grievances that are reported by its students and/ or staffs (teaching and non teaching).
- 3) Any student if felt victimized with violation of any above must report the same to GRC. The GRC shall be with the members to be appointed by Governing Body of the Narajole Raj College all grievances from any corner must be submitted in writing within 4 days from the date of alleged violation. The GRC shall now take a note of the same and shall direct disciplinary committee to thorough enquiry and impose appreciation as per rule. However, if the grievance is of any Sexual Harassment complaint, then the matter shall be referring to Internal Complaint Committee (ICC).

2. PURPOSE AND SCOPE

- 1) The basic purpose of grievance redressal committee (GRC) is to Prompt response, follow up and speedy disposal with accountability to all concerned students as well as staffs of Narajole Raj College the scope in generalize to ensure maintenance of cohesive and harmonious relation in students, Student and faculties, Student and Staff, GRC is to create and maintain such a tangible environment in which all victims students and staffs can be fearlessly express their grievances to the committee.
- 2) The GRC shall consider the grievances only those are received in writing about academic as well as non academic matters.

3. EXTENT AND APPLICABILITY

Students as a whole, nonteaching staff members, faculty members and other stakeholders during their tenure at Narajole Raj College.



4. DEFINITIONS

- 1) Grievance: means a formal complaint that includes any kind of discontent or dissatisfaction
- 2) **Grievant**: means a student, parent, staff member or group of students or parents or staff members submitting the grievance.
- 3) Days: means working days exclusive of Sundays, holidays or vacations as set forth in the academic calendar. In counting, the first day shall be the first full working day following the receipt of the grievance.

5. OBJECTIVES

- 1. Uphold the dignity of the institution by promoting cordial Student-Student relationship, Student-Teacher relationship and Staff-Staff relationships.
- 2. Develop a responsive and accountable attitude among the stakeholders, the by maintaining a harmonious atmosphere in the campus.
- 3. Ensure that grievances are resolved promptly, objectively and with sensitivity and incomplete confidentiality.
- 4. Ensure that the views of each grievanance and respondent a respected and that any party to a grievance is neither discriminated against nor victimized.
- 5. Advise stakeholders to respect the rights and dignity of one another, and not to behave in a vindictive manner towards any of them for any reason.

6. GRIEVANCEREDRESSALCOMMITTEE

1. As per UGC Guidelines and the direction of affiliated Vidyasagar University, the composition of the Narajole Raj College Student Grievance Redressal committee is as follows as per Governing Body Resolution 11/55 dated 6/10/2023 vide item no 16/4:

2. PROCEDURE FOR REDRESSAL OF GRIEVANCE

- 1. The College shall furnish, prominently, on its website and in its prospectus, all relevant information in respect of the Student Grievance Redressal Committee(s)
- 2. An aggrieved student, in case of academic grievance, shall first submit his/her complaint in writing to his/her mentor who shall resolve the grievance within two days. In case the mentor is unable to resolve the grievance, he/she shall forward it to the Chairperson of the Grievance Redressal Committee.
- 3. Committee chairperson shall convey a committee meeting within 2 days of receiving the complaint from the faculty mentor or from the aggrieved student/staffs in case he/she applies directly to the committee.
- 4. The chairperson shall attempt to resolve the grievance within a week of the receipt of the complaint and the action taken shall be reported to the mentor.
- 5. At all levels a fair hearing shall be given to all parties.



- e. Decisions with regard to recruitment and selection
- f. Anonymous and frivolous complaints will not be entertained/processed

5. AMENDMENTS

This policy will be reviewed periodically to rectify anomalies, if any, and to incorporate feedback received from the stakeholders through impact analysis and deliberations of the Focus Group, constituted by the College authority.



Policy Document

Introduction to Anti-Ragging Cell (ARC)

The Anti-Ragging Committee serves as a supervisory and advisory committee in sustaining a culture of ragging-free environments on college campuses. The Anti-Ragging Committee is active in developing strategies and action plans to combat the menace of ragging at the college through a variety of initiatives.

Objectives of ARC

- 1. ARC aims to prevent and safeguard students from ragging.
- To raise students' understanding about the negative impacts of ragging, its in fluence on human life, and the repercussions of participating in the act of ragging.
- 3. To receive and handle complaints through the ARC.
- 4. To initiate legal action as necessary, given the severity of ragging incidents.

What is Ragging?

Ragging includes any one or more of the following behaviours:

- Any behaviour on the part of one or more students that has the effect of making fun of, mistreating, or treating another student rudely, whether through written or spoken words or deeds.
- Engaging in boisterous or unruly behaviour by one or more students that irritates, burdens, injures physically or psychologically, or instils fear or apprehension in any new student or other student.
- Requesting that a student perform an act that they would not typically
 perform and that would cause them to feel ashamed, tormented or
 embarrassed in a way that would negatively impact their physical or mental
 health or the mental health of any other student.
- Any action taken by a senior student that hinders, interferes with, or upsets a
 freshmen or other student's routine academic activity.
- Making use of a new student's or any other student's assistance to finish acad emic assignments given to a single student or group of students.
- Any financial extortion or coerced spending placed on a new student or any other student by other pupils.
- Physical abuse, including sexual abuse, homosexual attacks, stripping, forcing obscene gestures, causing bodily harm, or posing a threat to health or person.



- Harassment of freshers or other students through spoken comments, emails, blogs, or public insults, including those who get enjoyment from their discomfort.
- Any behaviour that harms a student's mental health or self-confidence, either intentionally or unintentionally, or displays power, authority, or superiority over other students.

Duties of Ragging Grievant

- A written complaint has to be submitted to the any member of Anti-Ragging Cell (ARC) or to the Anti-Ragging Cell Box describing the ragging instance completely with date, time and place of happening.
- The complaint should contain the identity of the complainant and the identity of the alleged.
- 3. The confidentiality of the complainant and any other applicable issues shall be maintained Anti Ragging Committee

Redressal of Ragging Cases

In case of any ragging case reported in the college campus

- Members of the Anti-Ragging Cell (ARC) must quickly secure the complainant and/or victim, and take him to counselling.
- 2. The complainant or victim must submit a written complaint detailing the incident, including date, time, and location.
- Obtain the identification of the complainant and/or victim, including their name, semester, section, contact number, email address, and parent's name and contact information.
- Obtain the alleged's identity, including their name, branch, semester, section, contact number, email address, and parent's name and contact information.
- The complaint must be documented in a file with committee members.
- 6. A meeting will be conducted in conjunction with the chairman to settle the matt er and decide on action.
- 7. If found guilty, the AntiRagging Cell (ARC) will suggest appropriate actions to the institution's Head.

Actions

Punishment for ragging should be severe enough to deter future incidents. The institution's Anti-Ragging Committee will determine the appropriate punishment based on the facts of each ragging occurrence and its gravity.

Depending on the type and gravity of the offence as determined, the possible sanctions for individuals found guilty of ragging at the institution level shall be



one or a combination of the following:

- (i) Cancellation of admission
- (ii) Suspension from attending classes
- (iii) Withholding/withdrawing scholarship/fellowship and other benefits
- (iv) Debarring from appearing in any test/examination or other evaluation process (v) Withholding results
- (vi) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- (vii) Suspension/expulsion from the hostel
- (viii) Rustication from the institution for period ranging from 1 to 4 semesters
- (ix) Expulsion from the institution and consequent debarring from admission to any other institution.
- (x) Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

GUIDELINES ON GRIEVANCE REDRESSAL MECHANISM

1. PREAMBLE

- 1) Narajole Raj College affiliated to Vidyasagar University is dedicated to provide an environment towards a safe fair and harmonious learning and appropriate work environment. The college has its own full proof system for grievance redressal of students as well as for teaching and non teaching staff within a reasonable time.
- 2) The grievances those are considered for redressal are classified as Academy and non Academy matters. Those are such as work assessment, victimisation, attendance, charging of fees, examination conducting, harassment by fellow students or teachers or staffs as the case would be. Now to combat any grievance, grievance redressal cell (GRC) has been from as per UGC regulation to deal with day to day grievances that are reported by its students and/ or staffs (teaching and non teaching).
- 3) Any student if felt victimized with violation of any above must report the same to GRC. The GRC shall be with the members to be appointed by Governing Body of the Narajole Raj College all grievances from any corner must be submitted in writing within 4 days from the date of alleged violation. The GRC shall now take a note of the same and shall direct disciplinary committee to thorough enquiry and impose appreciation as per rule. However, if the grievance is of any Sexual Harassment complaint, then the matter shall be referring to Internal Complaint Committee (ICC).

2. PURPOSE AND SCOPE

- 1) The basic purpose of grievance redressal committee (GRC) is to Prompt response, follow up and speedy disposal with accountability to all concerned students as well as staffs of Narajole Raj College the scope in generalize to ensure maintenance of cohesive and harmonious relation in students, Student and faculties, Student and Staff, GRC is to create and maintain such a tangible environment in which all victims students and staffs can be fearlessly express their grievances to the committee.
- 2) The GRC shall consider the grievances only those are received in writing about academic as well as non academic matters.

3. EXTENT AND APPLICABILITY

Students as a whole, nonteaching staff members, faculty members and other stakeholders during their tenure at Narajole Raj College.



4. DEFINITIONS

- 1) Grievance: means a formal complaint that includes any kind of discontent or dissatisfaction
- 2) **Grievant**: means a student, parent, staff member or group of students or parents or staff members submitting the grievance.
- 3) Days: means working days exclusive of Sundays, holidays or vacations as set forth in the academic calendar. In counting, the first day shall be the first full working day following the receipt of the grievance.

5. OBJECTIVES

- 1. Uphold the dignity of the institution by promoting cordial Student-Student relationship, Student-Teacher relationship and Staff-Staff relationships.
- 2. Develop a responsive and accountable attitude among the stakeholders, the by maintaining a harmonious atmosphere in the campus.
- 3. Ensure that grievances are resolved promptly, objectively and with sensitivity and incomplete confidentiality.
- 4. Ensure that the views of each grievanance and respondent a respected and that any party to a grievance is neither discriminated against nor victimized.
- 5. Advise stakeholders to respect the rights and dignity of one another, and not to behave in a vindictive manner towards any of them for any reason.

6. GRIEVANCEREDRESSALCOMMITTEE

2. PROCEDURE FOR REDRESSAL OF GRIEVANCE

- 1. The College shall furnish, prominently, on its website and in its prospectus, all relevant information in respect of the Student Grievance Redressal Committee(s)
- 2. An aggrieved student, in case of academic grievance, shall first submit his/her complaint in writing to his/her mentor who shall resolve the grievance within two days. In case the mentor is unable to resolve the grievance, he/she shall forward it to the Chairperson of the Grievance Redressal Committee.
- 3. Committee chairperson shall convey a committee meeting within 2 days of receiving the complaint from the faculty mentor or from the aggrieved student/staffs in case he/she applies directly to the committee.
- 4. The chairperson shall attempt to resolve the grievance within a week of the receipt of the complaint and the action taken shall be reported to the mentor.
- 5. At all levels a fair hearing shall be given to all parties.



- f. Anonymous and frivolous complaints will not be entertained/processed

5. AMENDMENTS

This policy will be reviewed periodically to rectify anomalies, if any, and to incorporate feedback received from the stakeholders through impact analysis and deliberations of the Focus Group, constituted by the College authority.

Report of the Anti-ragging Cell Session – 2019-2020 Narajole Raj College Narajole, Paschim Medinipur


